**LEGAL:** All registrants are required to sign an SRCA Liability Waiver.

**COST:** \$250.00 per person, including spouses and guests. Non-members: \$300.00. All proceeds benefit the Slate Roofing Contractors Association, a 501c6 non-profit trade association.

**PRE-CONFERENCE TRAINING:** \$400.00/person. Six hour hands-on training course based on the SRCA *Installation Guidelines for Natural Quarried Roofing Slates*. We will have only limited space for this training session and will end registration when the course is filled. Those who complete the training will receive a certificate of completion. Training conducted by Chris Paulin and/or Barry Smith.

**CONFERENCE FEE INCLUDES:** Catered lunch Friday and Saturday, catered dinner Friday and Saturday, meetings and presentations, Friday reception, live music (four different performances over two nights), beverages, camping, and more.

**LOCATION:** Northwestern Pennsylvania at the SRCA home office site, 143 Forest Lane, Grove City, PA 16127, about 65 miles north of Pittsburgh, PA.

**ABOUT THE CONFERENCE:** We will have slate roofing professionals and interested parties from around the USA and from several foreign countries, gathering together to exchange knowledge and experience, tips, and tricks of the trade, over a weekend intended for learning, socializing, networking, and fun.

**AIRPORTS:** Greater Pittsburgh (PIT) is your best bet, but Youngstown, Cleveland and Akron (all in Ohio) and Erie, PA and Franklin, PA (FKL — [www.flyfranklin.org](http://www.flyfranklin.org)) are options. Allow an hour and a half to drive from the Pittsburgh airport to the site. There is plenty of parking space at the site. FKL flies to and from PIT for \$29.00 each way ([flysunairexpress.com](http://flysunairexpress.com)) and is only 20 minutes from the conference site, so this is a good option if you can fit it with your flight schedule.

**CAMPING ON SITE:** 143 wooded acres are available with a deep 6-acre quarry pond for fishing, swimming and canoeing. No electric or hose hookups. Children must be supervised at the lake at all times.

**FUND RAISING AUCTION:** Saturday night bring something to auction off! All proceeds will benefit the SRCA. Suggestions: tools, books, gift certificates, desserts, beverages, use your imagination! We will do a live auction conducted by volunteers.

**HOTELS:** are only 3 minutes away and an easy drive from the conference site. Motel 6 and Quality Inn, in Barkeyville, PA, are closest. Additional hotels are next to the Grove City Outlet Mall, about 20 minutes away by car.

**SPOUSE OR GUEST PROGRAM:** Shop at the Grove City Premium Outlets, 20 minutes away, rated as one of the top 20 outlet centers in the United States. There's also Historic Franklin, 20 minutes away, and New Wilmington Amish Country just a half hour away. Historic Oil City, birth place of the oil industry, including Oil Creek State Park and Drakes Well Museum is about 45 minutes away. We are going to rent a van to take the ladies on a day trip if there is enough interest.

**Assumption of Risk, Waiver of Claims,  
Release from Liability, and Promise to Indemnify**

This document is made as a condition to my admission to the Conference of the Slate Roofing Contractors Association of North America, Inc. (the "SRCA"), to be held in Barkeyville, Pennsylvania, on September 24-27, 2015 (the "Conference"), or as a condition to my entering upon the property where the Conference is held, or both.

**Assumption, Waiver, and Release for Benefit of Conference Providers**

As used in this document, the term "Conference providers" means these entities and individuals: the SRCA; the owner of the property where the Conference is to be held; the providers of services to the Conference; and the exhibitors and presenters at the Conference. The term also includes the shareholders, members, partners, directors, officers, employees, representatives, and agents of those entities and individuals.

- I release the Conference providers, and each of them, from all liability for any death, injury, illness, loss, or damage that I, any member of my family, or my property may suffer in connection with such Conference activities, whether caused by negligence or otherwise.

**Additional Assumption, Waiver, and Release**

### **Indemnification**

I promise to defend, indemnify, and hold harmless each Conference provider, Joseph C. Jenkins, and Joseph Jenkins, Inc., from and against:

- All loss, liabilities, and claims arising out of or relating to any act or omission committed at or in connection with the Conference, or upon or affecting the Jenkins property, by me, by any member of my family, or by any other person who accompanies me to the Conference, whether such act or omission is negligent or otherwise.
